Trustees Report

The Trustees present their report and financial statements for the period 1 April 2022 – 31 March 2023.

1. An introduction from our Chair

It has been my absolute pleasure to serve as the chair of Annabel's Angels and provide a report on my first full year of leading our amazing charitable trust.

This year has provided many challenges for the Charity, but we have also seen many incredible acts of kindness from Annabel's Angels supporters to help realise our aim of providing bespoke financial relief for local families undergoing treatment for cancer in the Derby and Derbyshire area.

We supported 67 families during the year, made possible by the generous fundraising support from local families and businesses. Our fundraising income totalled £28,378 and we are beyond grateful for all support – thank you.

Our scheme continues in partnership with the cancer support teams at the University Hospitals of Derby and Burton NHS (UHDB). This is invaluable to us, and our grant beneficiaries, and I pass on our wider thanks to the staff and team of volunteers at the Macmillan Information Centre based at the Royal Derby Hospital (part of the University Hospitals of Derby and Burton NHS Foundation Trust). Thanks also go to the team at Young Lives vs Cancer based in Nottingham City Hospitals and the support organisations and services working with families around Derbyshire at a more local level.

A particular mention should also be given to Rachael Beaumont who stood down as trustee in May 2022. Rachael was a familiar face at many fundraising and volunteering events, and has been a great trustee, supporter, and friend. We thank her so much for her time and support.

We welcomed a new trustee – Justina Nurse – into Annabel's Angels this year. Justina is a business owner and a long-time supporter of our work, with personal and professional connections with many fellow trustees. We are so happy to welcome her into our family.

Despite these changes, 2022/23 was a challenging year.

It became apparent during this year that decisions about our future were required. Our continued commitment to receiving public donations as our main means of income and the conflicting demands on trustees personal and professional lives yet continuing to give many hours of volunteer time, reached peak levels during this year. We took the decision to explore collaboration and partnership opportunities with other local charitable organisations to safeguard the grant scheme. These conversations continued throughout the year.

Running a charity places demands on every single trustee, and we take our responsibilities seriously and diligently.

My thanks are directed to our trustees - in particular our treasurer for his continued diligence – who have carefully put the needs of local families first, and contributed to our wider discussion about our future.

Together we have continued to juggle competing demands on our time and I thank them for their ongoing support.

2. Executive Summary

Annabel's Angels is a Registered Charitable Trust in England and Wales (Charity no 1157814). It was founded and launched in April 2014 to offer support and to help improve the quality of life for local families in Derbyshire living with cancer.

Rationale

Annabel's Angels was developed in response to a lack of financial support for local families in the Derby area while living with cancer. The founding members of the charity all had a close experience of living with cancer either personally or with a directly supportive role. The collective experiences within this core group of people enabled some very real ideas to be discussed with national and local health care providers and for the charity to be born.

The charity's mission statement is: **Improving quality of life for people living** with cancer in and around Derby.

In order to be eligible for Annabel's Angels grants programme an individual must fit all of the following criteria:

- Diagnosed or treated for cancer during the last twelve months;
- Living in and around Derby and/or being treated for cancer at the University Hospitals of Derby and Burton NHS Foundation Trust;
- The application must be approved and countersigned by a cancer nurse specialist, Macmillan Nurse or GP;
- The request for the grant must demonstrate a clear link to the impact of cancer and its treatment.

In addition to the above, the current annual household income must not exceed $\pounds 50,000$.

Structure

The charity is managed by a team of ten trustees, all of whom are volunteers. The trustees are drawn from a range of sectors and backgrounds including education, private sector, health, and adult social care.

There are three core roles within the charity, which are mandatory for all charities existing in England and Wales; Chairperson (Rachel Hayward), Treasurer (Mark Smith) and Secretary (Simon Hancox). All eleven trustees take turns to participate in the grant application decision making process by working in teams of three per application. Trustees also support the promotional work of the charity, both on and offline. In addition to our trustee volunteers, the charity also has a small team of volunteer fundraisers in Derby and further afield.

2022 - 2023

Annabel's Angels is now in its eighth year as a Registered Charitable Trust. Our relationship with the cancer services team within the University Hospitals of Derby and Burton NHS Foundation Trust continues to strengthen, despite the changes in staffing at the Hospital. We are very proud of this relationship and know that our close working methods enables us to keep grantees updated as to the progress of their application, and has shortened delays in processing.

Our promotional materials and grant application information is displayed at different sites around the hospital and its team members have delivered presentations at cancer nurse specialist team meetings and other departments around the hospital and the wider community.

The work of the charity has long been supported by a series of fundraising activities held in and outside of Derby throughout the year. Aside from

mandatory fees associated with running a charity all monies raised are used directly to fund grant applications to support families in need. It is difficult to single out those individuals and families who have raised money to support us – Justgiving amounts often are paid directly into our bank without any reference to the loved one. Therefore we thank everyone who has donated – your support truly makes our charity possible. Special thanks must be given to Leanne Thornewill and her family and friends who this year alone have raised over £6,000 for Annabel's Angels in memory of her father.

We have continued to increase our profile within the medical/health sector by working closely with practitioners based at the University Hospitals of Derby and Burton NHS Foundation Trust and by raising awareness within Derby City Council Adult Social Care teams, Nottingham City Hospitals and GP practices across Derbyshire. The charity continues to work closely with local businesses, some on a short-term ad-hoc basis and some in a 'Charity of the Year' relationship. We have been very fortunate in receiving support from businesses local to Derby. They have been exceptional during this period and we are very grateful. Special thanks to

The people we support

Whilst we know the number of families who need our support continues to rise, we have faced challenges in meeting this demand. As such we have at various times during the year, put our grant process on hold whilst we manage live applications. As a result we have supported a total of 67 families which averages out at 5.5 applications per month. Most of the grant application enquiries are submitted via the Macmillan Information Centre at the Royal Derby Hospital, although we have received applications directly from the East Midlands Children's and Young Persons' Integrated Cancer Service based at Nottingham Children's Hospital (for Derby based young people receiving specialist treatment) and Young Lives vs Cancer.

*As of 1 November 2023, the charity has approved 615 grant applications since its inception in 2014

Annabel's Angels offers financial assistance to people/families living with all types of cancer. Those we offer support to are from a wide range of backgrounds; they live across Derbyshire, are of different ages and live with a highly personalised diagnosis. Our offer of support is very much personalised towards the individual needs of the family.

Feedback

Feedback from grant applicants has been very positive. We strive to capture feedback from all people we support but we recognise that this isn't always possible and we aim for a return rate of 75%. Some feedback received this year is as follows:

"I write today firstly to thank you for the care and support that you offered to our mum during her last bit of time with us. You donated money to our mum to help her be comfortable through the end of her life. Your donation contributed to mum treating herself to a new mattress for the first time in over 20 years. She was bed bound a lot towards the end and the comfort it provided when never stopped been thankful for. It made her laugh and smile picking it and she was so thankful. A memory we will forever cherish. Thank you.

One of her wishes before passing was to raise some money to give back for your charity. A way of her thanking you. So she demanded on arranging her funeral that a charity box be made up for yourselves. Otherwise people couldn't enter her wake! We delivered this and have managed to raise a little money. I know mum would be happy and that's what matters the most. "

2022 - 2023

Our aims - and achievements - are:

- To support 90 individuals/families via its grants programme during 2022/23 (67 families supported);
- To identify and work with 10 new Annabel's Angels business champions within local businesses across Derbyshire (5 new fundraising organisations this year);
- To achieve a fundraising target of £30,000 during 2022/23 (£28,378 received).

In order to support the needs of future individuals/families and their grant requests, it is important for Annabel's Angels to raise a minimum of £30,000 fundraising income for 2022/23. If, for example, the charity is to realise its aim of supporting 90 individuals/families, at the current maximum grant application amount of £250 per family, then this equates to a fundraising income of £22,500. It is important to ensure we manage a balanced budget whereby our expenditure and outgoings are within our fundraising revenue.

The restrictions on social distancing and the impact on external events cause concern amongst the trustees, particularly when faced with considerable increase in applications.

Income received increased during 2022/23 – we received £28,378 - (in 2021/22, a total of £18,311 and 2020/21 we received £38,885), particularly bolstered by the generous donation facilitated by Markeaton Crematorium. Nominated by the Bereavement Services staff team at the Crematorium, the £12,000 donation has come via the ICCM Recycling of Metals Scheme. Our continued thanks go to the staff team at the Crematorium for nominating us for such an award.

"In a time when environmental issues are becoming more and more important to us all, we are realising that we cannot continue practices that are detrimental to our environment, without accepting the consequences of our actions sometime in the future.

The decision to recycle metals remaining after cremation is an environmentally responsible one, and the fact that all proceeds raised are donated to charity, means recycling can have both an environmental and a broader social impact benefit.

A very Special thank you must be given to the bereaved families who have given their consent to recycle any metals." Glynn Jones, Bereavement Services

Continued careful management of our finances enabled us to meet the requests for support and trustees discussed regularly our intentions regarding methods and opportunities for fundraising.

We held our trustee meetings during the year. As we continue to manage our grant approval process via secure WhatsApp, no delays were experienced together with continued posting of online vouchers to recipients' addresses. In this way we continue to process applications promptly and safely.

The Derby 10 mile event went ahead on 20 November 2022, with Annabel's Angels appearing again as the headline charity partner. We also had presence and fundraising opportunities at the Derby 10k, and ramathon events with support from local runners which secures much needed funds, as well as publicity and awareness of our grant scheme.

Trustees' responsibilities in relation to the financial statements

The Trustees are responsible for preparing a trustees' annual report and financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice). The trustees consider that an audit is not required for this financial year under section 144 (2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed – see appendices.

It is a legal requirement for the trustees to prepare financial statements for each financial year. Under that law the trustees have elected to prepare the financial statements in accordance with United Kingdom Generally Accepted Accounting Practice (Financial Reporting Standard 102 and applicable law). The trustees can only approve the financial statements once they are satisfied that they give a true and fair view of the state of financial affairs of the charity including income and expenditure for the relevant period. In preparing these financial statements, the trustees are required to:

- Make judgements and estimates that are reasonable and prudent;
- Select suitable accounting policies and then apply them consistently;
- Observe the methods and principles in the Charities SORP (Statement of Recommended Practice);
- State whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- Prepare the financial statements on the 'going concern' basis unless it is inappropriate to presume that the company will continue in business.

The trustees are responsible for keeping adequate and accurate accounting records that are sufficient to show and explain the charity's transactions and disclose at any time the financial position of the charity. The trustees are also responsible for safeguarding the assets of the charity and for taking practicable steps for prevention and detection of fraud and/or any other irregularities.

Disclosure of information to independent examiners

Objects

The Charity's objects (as listed on the Charity Commission website) are specifically restricted to the following:

"To promote and protect the physical and mental health of cancer patients, their families and carers in Derby and the surrounding area particularly but not exclusively through the provision of grants of financial assistance and practical and emotional support."

4. What we do

Our Mission Statement

Improving the quality of life for people living with cancer in Derby and Derbyshire.

We aim to reduce some of the isolation and the pressures associated with living with cancer. Many people we come into contact with have experienced financial difficulties as a result of their cancer such as:

- A drop in regular income due to no longer being able to work;
- A change in body shape (through treatment) which will mean the purchase of new clothing;
- Expensive travel costs to/from regular cancer appointments.
- Childcare costs while a parent is undergoing treatment.

Our Values

The trustees recognise that for the charity to run effectively it is important for the trustees and volunteers to always uphold the charity's core principles and values:

- Responsive
- Diverse
- Person-centred
- Transparent
- Local

Our Activities

The charity manages a small grants programme for individuals/families living with cancer in and around Derby. The grants programme is funded by public donations. A grant application is completed by an individual, checked and countersigned by a cancer nurse specialist, and submitted to Annabel's Angels for consideration. The grant application panel makes a decision on the information provided and then liaises with the applicant. The panel may need to check details with the applicant, seek further information, and, on occasion, suggest alternative items/services for purchase. Items/services are purchased on behalf of the applicant and delivered/handed to the applicant by the charity. Grants are currently up to £250 per application and are limited to one grant per family per year.

The charity also supports local cancer support groups by providing financial assistance for local groups and initiatives working to improve life outcomes for cancer patients and families. Examples are as follows:

- Room hire costs for cancer type support groups to meet up
- Costs of a health-care trainer to set up and deliver health and wellbeing sessions for cancer patients

The process of applying for a Partnerships Fund grant is similar to the Public Fund. An application form is requested, completed, sent/emailed back to the team for consideration along with any estimates for costs.

5. Achievements and Goals

Annabel's Angels has grown at a steady pace since its inception. As expected, year one (2014 – 2015) saw a lot of media exposure which helped to create teams of fundraisers keen to raise funds to meet the gaps in support for local families. The relationship with the University Hospitals of Derby and Burton NHS Foundation Trust and associated health care professionals took a while to develop so, consequently, in year one the charity only received a handful of referrals from individuals/families.

Fast forward several years, and 2022-23 has seen a significant reduction, reflective of the legacy from Covid and the rise in living expenses experienced by the local community. The 2022-23 period saw:-

- an income of £28,378, compared to £18,311 in 2021/22.
- 67 families were supported during the year compared with 113 in 2021-22).
- £16,470 was spent on items/services purchased for families against a figure of £28,216 in 2021-22.

Goals

2022 -2023

The grants programme continues to work well for families - based on feedback received from grant recipients. The trustees have set a target of reaching and supporting 90 new families in 2023. In order to do this we need to maintain our relationships with healthcare professionals and maintain our fundraising revenue to match the anticipated interest. 12 month objectives are set out below:

- To administer 90 support grants for individuals/families;
- To achieve a minimum fundraising income of £30,000 during the year 2023 - 2024;

6. The Public Benefit Need

What is the Public Benefit Need?

To promote and protect the physical and mental health of cancer patients, their families and carers in Derby and the surrounding area.

Who will benefit from the organisation's activities?

The charity focuses on supporting individuals and families affected by cancer living in, or being treated for cancer, in Derby. Grant applicants will have been diagnosed or treated for cancer during the last twelve months. In addition to the above, the current annual household income must not exceed £50,000.

How will they benefit?

The charity seeks to address some of the additional costs and issues associated with the diagnosis of cancer. Some of these are as follows:

- Frequent trips to and from the hospital
- Change in body shape due to treatment
- Isolation from friends/family/work colleagues
- A drop in finance due to being off work

The charity helps to address some of the issues by offering relief of some temporary need as a result of a cancer diagnosis. The charity helps to signpost applicants to other forms of support – cancer type groups, adult social care teams and more.

What similar services are available?

Macmillan Cancer Support offers a national discretionary support grant to help people with costs caused by or related to their cancer. Their discretionary grant scheme is means tested and covers the United Kingdom. There are several cancer type specific charities operating in and around the Derby area that offer support grants to people living with cancer. One example is the **Derby Breast Cancer Support Group**. The group offers emotional and practical support to people living with breast cancer while also offering a small discretionary grant scheme and therapy days.

Annabel's Angels offers support to people living with cancer in and around the Derby area. The support is available to individuals and families/carers of any age living with any cancer type.

What is the unfulfilled need?

As far as we are aware, there is no other charity offering financial assistance to people living with all types of cancer and all ages exclusively to and around Derby.

How will the organisation integrate with other service providers?

Annabel's Angels works closely with the University Hospitals of Derby and Burton NHS Foundation Trust teams to ensure the information exchange is professional, timely and accurate. Referral systems are in place for other organisations to refer to us. We have worked with other charities and support groups locally and nationally such as Derby Breast Cancer Support Group, Mummy's Star and Young Lives vs Cancer.

7. Quality and Performance Monitoring

Key Performance Indicators:

- Number of grants distributed to people living with cancer in Derby
- Number of people actively following/using our Annabel's Angels social media channels
- Fundraising income is sufficient enough to meet the ongoing costs of our grant scheme
- Number of media articles published promoting the charity and issues affecting people living with cancer
- Number of events organised or attended in line with our work

Measurement of Key Performance Indicators:

- Grant applications analysed and agreed by trustees. Applications are documented and evidenced. The team adheres to our criteria guidelines
- Social Media administrators monitor our online presence
- Funds are banked swiftly and appropriately. Funds are available and accessible to Chairperson and Treasurer.
- Clear audit trails exist regarding the work of the charity
- Grant support requests are responded to within 14 working days.

Reporting of Key Performance Indicators:

- Documentation and a performance review is shared at team meetings
- Treasurer's report is an agenda item at every team meeting
- Treasurer and/or the Chairperson make financial purchases relating to grant applications and other items in line with the work of the charity.
 Paperwork is made available to fellow trustees.
- Evidence trail on Social Media and emails.

8. Promotion and Marketing

Annabel's Angels recognises the need for promotion in order to reach and support more local people living with cancer. Posters, leaflets and banners are on display at the University Hospitals of Derby and Burton NHS Foundation Trust sites and a range of businesses in the Derby area. The charity understands the importance of keeping a balanced budget in terms of its marketing spend – the trustees have set an annual limit of 15% to be used on promotional/marketing materials.

The charity recognised the need to connect and maintain relationships with local businesses. The introduction of targets to recruit and work with local business ambassadors should help the charity spread the word and reach more families while also supporting business employees to develop and build on their workforce competencies – leadership, project management, interpersonal skills and more.

The charity has a building following on Twitter/X and Facebook - we use both of these channels to keep our community informed of our grant giving but also communicate when sporting events are available such as the Derby 10 mile. This has continued to work well for the charity and is fast becoming a strong area of regular promotion and awareness raising.

We are still able to support families in need in order to reach our annual target, whilst opportunities for partnership and collaboration will be explored. Performance will be monitored and reviewed at trustee meetings to ensure progress is made against our set targets.
